

Flexible Plan

- No Commitment
- Monthly Billing Cycle
- Add users at any time for additional monthly cost
- Remove users at any time (reduces monthly cost)
- Cancel services at any time without a penalty

- Add users at any time for additional cost for the remaining period of contract.
- Remove users only when you renew the annual contract. Until then, you pay for all purchased licenses.
- Must pay annual commitment (even if you cancel early).

Payment terms

• When you sign up for Google Workspace, you get a 30-day free trial. We will contact you to confirm the payment plans when the trial ends.

For Annual Payment Plans:

• We will send the bill 7 days before end of the trial with the payment term - Net 7.

For Monthly Payment Plans:

- We will send the bill 7 days before end of the month with the payment term Net 7.
- Each month, you're billed for the number of users your organization had per day during the previous month.

 Please note that a prorated payment for a partial month can happen.
- Note: The currency exchange rate will be charged according to the rate set by RealHost Myanmar.


